

## WHAT'S IN THE BOX TERMS & CONDITIONS

**THESE TERMS & CONDITIONS (HEREINAFTER REFERRED TO AS THE "T&Cs") ARE APPLICABLE TO ALL THE PARTICIPANTS/CONTESTANTS OF "WHAT'S IN THE BOX" (HEREINAFTER REFERRED TO AS THE "CONTEST") PROMOTED / ORGANIZED BY M/S HT MUSIC AND ENTERTAINMENT COMPANY LIMITED UNDER THE NAME 'FEVER 91.9 FM' IN CHENNAI' (HEREINAFTER REFERRED TO AS "FEVER FM"). THESE T&Cs CAN BE AMENDED OR VARIED FROM TIME TO TIME BY FEVER FM. THE CONTESTANT MUST CAREFULLY READ AND AGREE TO THE T&Cs BEFORE PARTICIPATING IN THE AFOREMENTIONED CONTEST.**

### INTRODUCTION

2.2 **Mechanics of the Contest:** In order for the participant to take part in the contest:

(i) **Phase 1 On-air Registration:** The RJ will invite listeners to participate and register in the "What's in the box" contest. To participate in the Content, the listeners will have to type their "NAME" (space) "Whatsinthebox" and send it on our WhatsApp number 8056591919 to register himself/herself to the Contest.

(ii) **Phase 2 | On- air Qualifying Round:**

- (a) The RJs will select the participants through randomiser;
- (b) The RJ will call the two selected participants each day during the Contest Period and ask questions based on Chennai city;
- (c) The first 20 participants who answer correctly will move to the final round and will be invited to participate in the grand finale On-ground activity at the Marina Mall located in OMR, Chennai on 23rd October, 2022 between 6pm to 7pm to win the prizes;
